## OFFICIAL LOCAL VISITOR EXPERIENCE PHOTO CONTEST RULES (the “Contest”)

### CONTEST PERIOD

The Contest period begins 12:01 AM Eastern Time on May 11 2018, and ends at 4:59 PM Eastern Time on October 30, 2018.

The Friends of the Greenbelt Foundation (the Foundation) has partnered with the Ontario Beverage Network (OBN) to execute the contest. OBN will manage the contest on behalf of the Friends of the Greenbelt Foundation. The Foundation retains full ownership of the contest and takes full responsibility that the Contest is conducted in accordance with the laws of the province of Ontario.

### CONTEST ELIGIBILITY

#### Who is Eligible?

- The Contest is open to all legal residents of Ontario:  
who have an Instagram, facebook or Twitter account;
- AND**
- who submit one or more visitor experience photos taken at any of the attractions listed on the Brewery Discovery Routes Map to Instagram or Twitter using the #BrewRoutesON hashtag and to [facebook.com/breweryroutes](https://www.facebook.com/breweryroutes) page

#### Each submitted photo is a distinct entry

All winners **must provide a valid email address** upon request. A valid email address is defined in all cases as an address which (a) represents a real business or individual in Ontario and (b) includes the minimum contact information necessary for Friends of the Greenbelt Foundation (“the Foundation”) staff to contact the entrant by email. For contest winners under the age of 18, a legal parent or guardian must give consent to accept the prize.

#### Who is Not Eligible?

### Chances of Winning
